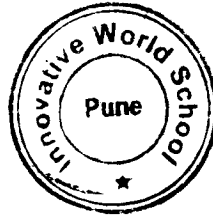

1. School Updates: Term-1 (2024-25)

Student Council was formed and an investiture ceremony was conducted, SMC meeting-01 was held, Elementary Drawing Examination: Std. VII and VIII (Basic level) conducted, 2nd CBSE Teacher's Training conducted on: 17th & 18th August, Sanskrit Shloka Competition conducted in the new format, Question Paper (VI to VIII) as per CBSE pattern, Term-1 Examination: Started from 10th September, Olympiad Exams in October Month and Educational Field Visit.

a. School Initiatives

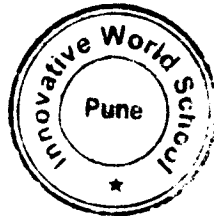
Class-wise Parent Counselling is going on, organised Interschool Patriotic Song Competition and received 3rd position among 18 schools, Inaugurated E-Magazine "Pratibimb" 1st Edition, focus on child's discipline, Tiranga Rally, School registered for the District Sports Competitions.

2. Discussion on Fee Finalization for the A.Y. 2025-26 & 2026-27

The executive committee member and the Management representative explained the existing Fee Structure for the academic year 2023-24 & 2024-25. It was explained that the revised fee structure proposed in the meeting would be fixed for the next 2 academic years 2025-26 & 2026-27.

- a) The fee revision is essential keeping in mind the operational costs like appointment of new teachers, and non-teaching staff, purchase of furniture, equipment, instruments, library books, sports material, and other developments will be required in 2025-26 and 2026-27, along with inflation rate declared by the Government of India.
- b) **Nursery & Jr. KG classes:** We are happy to share that despite no increment for the last 05 academic years i.e. since the time of inception of the school, no fee revision has been proposed by management for Nursery & Jr. KG classes even though the school is permitted to follow a biennial (once every 2 years) fee revision Act.
- c) **Sr. KG.:** - We are further happy to share that the management has not proposed the Fee increase for Sr. KG, which is also 0 %, which means the same fee structure will continue till the A.Y. 2026-27.
- d) **Classes I to IX:** - It is only classes I-IX, the fee increase is proposed by 06.6% of the A.Y. 2024-25 fees, for the next two academic years 2025-26 & 2026-27. (increase by only ₹ 317.86/per month).

The Management apprised the members that the Executive Committee members 2024-25 are responsible for endorsing the fee proposal. The detailed discussion took place on proposed fee.

The proposed fee increase for Classes I to IX was appreciated and accepted by all Present member except one of the members of EPTA 2024-25 on Saturday, September 28, 2024 and accepted the same.

The Total Present Members were: 15 Members

Accepted the proposed Fee Increase :14 Members

Opposed the Fees increase :01 Members

The Resolution for increased fee for Classes I to IX is passed by Majority.

The One-time fees for new Admission (A.Y. 2025-26) will be changed accordingly as per the approved increase in fees in the fees of A.Y. 2024-25.

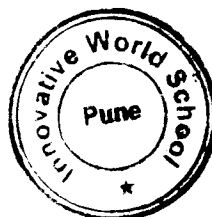
Resolution is Passed by Majority.



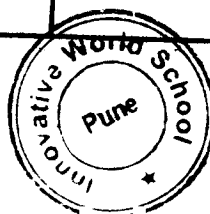
