Agenda VIII Fees Fixation for A.Y 2022-23 as per New Infrastructural Building

Chairperson Mrs. Shital Patil explained the process of fee fixation in compliance with the Maharashtra Educational Institution Regulation Fee Act 2011. The class-wise fee structure proposed by the management is as follows:

- **Pre-primary:** ₹30,000 per annum
- **Classes 1 to 4:** ₹35,000 per annum
- **Classes 5 to 8:** ₹40,000 per annum

The increase in fees is justified by the development of additional facilities, including a separate building, play area, new benches, labs, and a library.

Mrs. Jyoti Chordiya expressed parents' concerns regarding the fee hike, which was addressed by the school management. It was also suggested by Mr. Nandkishor Kolhe to distribute the payment into four installments instead of three, which the Chairman agreed to implement from A.Y 2022-23.

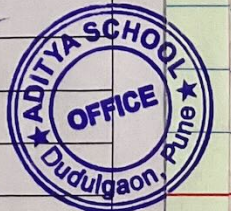
