ORDER

This is the application for transfer of management of Nirmal Bethany High School from The Malankara Catholic Association to the trust Bethany Ashram. This School Nirmal Bethany High School is run by The Malankara Catholic Association. It is true that the matter relating to the transfer of management of the school is within the jurisdiction of the Director of Education, however, being it is the school run by the trust, the permission of this Authority is required. This Authority has no objection to transfer the management, if the compliance of other rules relating to the transfer of management are made. However, the property of the school immovable and movable shall not be transferred under the guise of the transfer of management. The property of the trust is in possession of the school Nirmal Bethany High School to remain and continue to be the property of The Malankara Catholic Association. Necessary change be effected in the P.T.R. Inform the concerned accordingly.
