- 5) In case of premature withdrawal, interest will be paid at:
 - a) the rate prevailing on the date of deposit for the tenure the deposit or the withdrawn amount remained with the Bank or at the contracted rate, whichever is lower post deducting applicable penal charge for premature withdrawal as per Terms & Conditions of the Bank.
 - b) For FCNR (B)/ NRE deposits, in addition to the above point, no interest will be paid on the principal amount withdrawn from FCNR (B) / NRE term deposit before completion of one year.
- 6) For Fixed Deposits with a tenure below 181 days, interest will be calculated and paid on maturity as per simple interest method.
- 7) Repayment / renewal of deposit shall be effected as per the maturity instructions recorded with the Bank at the time of booking the Fixed Deposit.
- 8) In absence of maturity instructions, the Fixed Deposit will be renewed automatically, without any liability to the Bank, for the same tenure and at the interest rate prevailing on the date of renewal.
- 9) Where maturity instructions are for repayment and not for renewal, interest will cease to be payable at the end period of the deposit.
- 10) Facility of renewal with retrospective effect is not available with respect to a deposit that has been overdue beyond 14 days.
- 11) Any change of maturity instructions shall be intimated to the Bank minimum 7 days prior to maturity of deposit
- 12) All communications to the Bank should consist of the Fixed Deposit Number/Customer Relationship Number
- 13) Any change of address should be communicated to the Bank along with acceptable address proof document for the new address.
- 14) The calculation of interest is basis 365 days in a year for deposits booked in a non-leap year and 366 days in a year for fixed deposits booked in a leap year.
