TERMS AND CONDITIONS

- The fee structure for [Elpro International School, Chinchwad campus] has been declared for the forthcoming period of 5 years as per the terms of the MEI Fee Regulations and the rules and regulations made thereunder. [The fee structure for the subsequent 5 years will be declared by the school in due course as per the terms of the MEI Fee Regulations as per the conditions prevailing at such time.

- Parents are requested to make the payment of the prescribed fees for their wards as per the School rules and policies. No partial payment of the fee will be accepted in any case.
- The fees are to be paid strictly in accordance with the payment schedule indicated above. The fees can be paid by way of [cheque & edusprint]. No cash payment of the fees will be accepted.
- If the fees are not deposited by the relevant due date, late fee at the rate of INR [85/-] will be charged from the date on which the fees were originally due and upto the date on which the amounts are deposited.
- Each guardian / parent is responsible for ensuring that the fees of their ward are paid within the indicated period. Failure to do so may result in the ward not being permitted to attend school sessions and consequentially result in cancellation of the admission of the child.

Withdrawals

- (A). In case Parent (s) are desirous of withdrawing their ward (s) from the school and do not wish to continue for the subsequent academic year will have to give in writing a notice for such withdrawal latest by 20th Feb of that academic session otherwise it will be assumed that ward is continuing for the next academic year and will have to pay the fee as per as per above fee schedule & fee policy.
- (B). Urgent or shorter requests for withdrawal of a ward due to compulsion such as transfer of parents or for health reason will be considered by the school Management on a case-to-case basis.
- (C). Students can be asked to leave the school on disciplinary grounds. In such eventuality, the concerned parent (s) shall be liable to clear all such dues that may be outstanding on such date of removal of the Student from the rolls of the School.
- (D). For withdrawals, parent (s) must ensure that the Caution Money deposited and the Transfer Certificate must be taken together within three months' time for the date of the request for withdrawal. Caution money will be refundable subject to submission of the original deposit receipt, at the time of claiming the refund. In case of a lapse on the parent (s) part to claim the above, it becomes mandatory for the parents to pay the Term's tuition fee for their ward(s) at the time of receiving the documents. No refund of fees will be made.
- (E). Transfer Certificates are not issued until all dues of the school are settled.
- (F). Fee once paid will not be refunded if the child leave the school in the middle of the year.

Withdrawal Refund Policy

- Students wishing to withdraw need to submit an application/letter in the prescribed form to the school office stating the effective date of withdrawal subject to clause stated above. The said withdrawal form is available at the school reception. Submission of original Caution Deposit slip is mandatory along with the form. Withdrawals will be effective from the date letter is officially received, or a later date, if specified by the student in writing. Withdrawals may not be retroactive.
- Parents and guardians are required to save the receipt issued to them and produce the same as proof of payment of fee, if requested.
