grant basis.

In relaxation of the ban imposed on opening of new secondary schools, Government is pleased to direct that the Managements mentioned in statement 'A' attached should be granted permission to open new secondary schools with English medium on permanently no grant basis from June, 1978 at the place specified against each subject to the condition that the Managements give a clear undertaking that they will not seek any Government grant or reimbursement of fees or behalf of E.B.C. concession holders at any time in future. The permission is further subject to the verification that the financial position of the Managements concerned is sound. The undertaking to be obtained from the Management should be signed by the President and the office bearers of the managements and the same should be preserved in your office as a permanent record.
