- 4. The management should collect the tuition fee and special fee etc. as prescribed by Lee Regulation Committee appointed by the State Government.

- 6. The management should follow the State Board syllabus for Classes from 1 to 21
- 7 The school should tollow the three language formula till 8th Standard and Marathi is H. Language.

- They should abide by the State Government Acts, rule, regulations and orders issued from time 17.
- The school shall not be eligible for any kind of financial grant-in-aid from the Government and must be run only on sell financing basis
- The no objection certificate is applicable till class XII. Provided the school must apply to 19. renewal after a period of every 3 years as mentioned in clause (1)
- The State Government reserves the rights to carry out academic /audit inspection of the school. It will be manufacety to the school to provide any information at any time required by the Gavernment
