This meeting was chaired by the Principal Dr. Shilpa Jejurkar.

- Total 08 parent members out of 12 were present in the meeting. Management representative Mrs. Pallavi Mishra, Head Academics & Operations was also present for this meeting. The Meeting was taken up after having established that the requisite quorum was present. Ms. Sanju Bharti, Secretary (EPTA) welcomed the parents and requested Principal to address the meeting.
- Principal briefed about the Academic activities which was taken during 1<sup>st</sup> Term of this academic Year 2023-24. She also explained the co-scholastic activities conducted in previous term.
- In continuation with the above, The Principal Dr. Shilpa Jejurkar informed the CBSE Board Exam 100 % results for the AY 2022-23 were total 30 students appeared. Also, the achievement of the students in various curricular and co-curricular activities in Term I were shared with the EPTA Members.
- Chairperson and Principal Dr. Shilpa Jejurkar introduced Head Academics and Operations Mrs. Pallavi Mishra Ma'am appointed as Management Representative for EPTA Committee and requested her to address the meeting and proceed further.
- Mrs. Pallavi Mishra Ma'am, Management representative mentioned to the parents that as per the Fee Regulation Act the fees can be incremented after every two years, hence the next fee revision is due for the AY 2024-25 & 2025-26 by 15% of the previous approved fees.
- Further, Dr. Shilpa Jejurkar Ma'am stated that the last fee hike took place in December 2021 for the AY 2022-23 & 2023-24 and she presented the proposal of Fee Revision for the Academic Year 2024-25 & 2025-26 through a PPT and explained the proposed fees.
- In continuation to the above point Mrs. Pallavi Mishra Ma'am informed that, as per the provisions of section 6(1)(b) of the Maharashtra Educational Institutions (Regulation of Fee), Act, 2011 and The Maharashtra Educational Institutions (Regulation of Fee), Act, 2011 (Amendment), and after following due procedure laid down in Maharashtra Educational Institutions (Regulation of Fee), Rules 2016 the revised Annual Fees for the Academic Year
