1) The ICSE curriculum upto class 9 follows CISCE guidelines. Core subjects include English language and literature, II language (Hindi / Marathi) Maths science (EVS for classes 1-2) integrated upto std 5. Split into Physics, Chemistry and Biology from class 6 and Social Studies from class 3 onwards. Other subjects are Computer, Robotics, Art and Craft Speech and Drama, Music, Dance, P.E, Karate, Value Education, Home Science and SUPW.

2) System of Pupil Assessment

The school follows CISCE guidelines for Pupil assessment for Summative and formative evaluations. For Grade 1-2, the split is 66.67% formative and 33.33% Summative. For Grade 3-4, 53.33% formative and 46.67% Summative. Grade 5-7, 40% formative, 60% Summative. Grade 8-9 formative 26.67% and 73.33% Summative.
