- Required documents: To obtain a Permanent driving license in India, including proof of age, address and identity.
- Documents Clearance: Driving License, Character Certificate, Medical Certificate, Vehicle Registration Certificate, Proof of Pollution Under Control (PUC), Insurance Certificate, Permit (If applicable).

RTO Rules: include requirements for valid permits, fitness certifications and speed governors. School vans must also have seating capacity limits. Additionally, school vans should be equipped with necessary safety features like fire extinguishers, first-aid kits and horizontal grills on windows.

- > Discipline: Good behavior, proper communication, Safe driving etc.
- Requirement of care taker in the buses: It is a vital requirement in school buses, to ensure the safety and wellbeing of students during transportation. The caretaker's role is to assist students in boarding and maintain order and discipline and ensure the bus is clean and safe.
