Here Jodo will give parents 6 payment instalments towards their total Annual Tuition Fees. MIT- WPS gives Parents 3% discount on total fees if the payment is done in one. Here the same discount will be given to JODO & JODO will be giving Parents 6 instalments to pay the fees.

- b. **Jodo Flex**: Jodo facilitates payment of Payable Fee through recurring payments product through e-NACH. Jodo works with Partners to facilitate a platform, through which Qualified Parents can set up mandates (ECS), and accordingly, on the due dates, money is auto debited from Qualified Parents account (with prior reminder) and settled to the Client's account.
- c. **Jodo Pay**: Jodo facilitates instant payment solutions through Partners (such as payment gateway), and enables the clients to share payment links through emails etc for smooth payments.




