**8. Financial Matters : Fee, Budget & Finance :**


**8.1 Preamble :** The matter of Revision in fee for the academic year 2024-2025 and 2025-2026 was placed by head Mistress, DES Secondary School in PTA meeting. The PTA unanimously agreed with 15% rise in fees i.e. Total Fee Rs. 49800/- p.a. (Tuition Fee 42900/- & Term Fee Rs. 6900/-) for the Academic Year 2024-2025 and 2025-2026.

**8.1 DES-SSTR-05/16.12.2023 : Revision in fee Rate for the Academic Year 2024—2025 & 2025-2026.:** Resolved that it be recommended to GB through Finance Committee that, the fees for the students from standard 5<sup>th</sup> to 10<sup>th</sup> at DES Secondary School for the academic year 2024—2025 & 2025-2026 be received as per the following details

## DES SECONDARY SCHOOL PTA RESOLUTION

The H.M. D.E.S. Secondary School discussed the matter pertaining to the increase in fees with effect from the Academic Year 2024-2025. The H.M. has informed all the members of P.T.A., the reasons for the increase in such fees, that is due to increase in the expenditure on account of salaries of Teaching and Non – teaching staff, and the increase in non – salary expenditure due to inflationary trends.

The H.M. has informed that though the expenditure is increasing day by day, the management proposes to keep the rise at a very minimum level, and hence has informed that a very much minimum rise is proposed, and that the revised fee should be Rs. 49,800/- (Rs. Forty-Nine Thousand Eight Hundred only) i.e. Tuition Fees of Rs. 42,900/- & Term Fees of Rs. 6,900/- for the next two academic years, that is academic year 2024-2025 and the academic year 2025-2026

After due discussions all the members of Parents Teachers Association, DES Secondary School unanimously agreed for the suggested fee rise for the academic years 2024-2025 and 2025-2026 as follows,

**Tuition Fees :- Rs. 42,900/- P.A.**

**Term Fees :- Rs. 6,900/- ( For 2 Terms )**

**Total :- Rs. 49,800/- P.A.**

Hence the resolution.

**Resolution** – “Resolved that the members of the PTA unanimously agrees with the fee rise of Rs. 6,500/- p.a. for the academic year 2024-2025 and 2025-2026 and authorizes the H.M. to charge the fees of Rs. 49,800/- p.a. (i.e. Tuition Fees of Rs. 42,900/- & Term Fees of Rs. 6,900/-) for the academic year 2024-2025 and 2025-2026 be and is hereby approved and confirmed.”
