Resolution of the Executive Committee of PTA of, Kannada Sangha Pune's, Dr. Kalmadi Shamaraao High School, Gat No. 147/8-9-10, Park Marina Road, Prathamesh Park, Mouje Baner, Tal. Haveli, Pune 411045 about the Fee proposed by the School management for the academic year 2024-25, 2025-26.

1. We the member of the executive committee of the PTA of (Kannada Sangha Pune's, Dr. Kalmadi Shamaraao High School, Gat No. 147/8-9-10, Park Marina Road, Prathamesh Park, Mouje Baner, Tal. Haveli, Pune 411045) school have unanimously decided that the Fees for students of our school from Grade 1 to Grade 9 is to be increased by 18% for two academic years i.e.. 2024-25 & 2025-26.
2. The impact of increase will be calculated on the Fees which was in force for the academic year 2023-24 under the components of (Tuition fee, Term fee & PTA contribution). Every component will be increased as decided unanimously.
3. For new admissions additional Registration & Admission Process Fee - Rs. 4982/- (Grade 1 to 4) & Rs. 5082 (Grade 5 to 9) and One-time refundable deposit Rs. 50,000/- (Fifty thousand only) will be charged.
