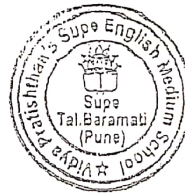
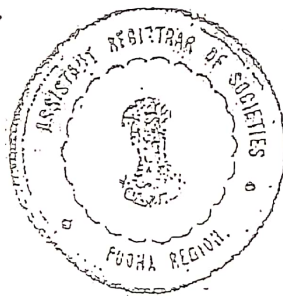

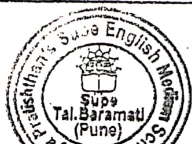

22 RULES AND REGULATIONS 22

1. Name of the institution will be **VIDYA PRATISHTHAN** and the head office of the institution will be at Vidyanagar, Bhigwan Road, Baramati (Pune) 413 133.
2. Area of Activity :- India
3. The Aims And Objectives Of The Institutions :-
 - a) To make lodging and boarding arrangements for the education of poor and bright students (includes female students also).
 - b) To acquire and run hostels for needy and deserving students.
 - c) To provide books and other educational material to needy and deserving students.
 - d) To provide scholarships, prizes and any other help to needy and deserving students.
 - e) To provide vocational and curricular guidance to stimulate them and to arrange for their medical check-up.
 - f) To provide all facilities for sports and games and to encourage participants in games and sports.
 - g) To establish & run new institutions for the backward and poor people & help the educational institutions in the same area of activity.
 - h) To establish or make available school and develop facilities to run them; similarly to establish and develop facilities of education for infants and also establish and develop primary, secondary, higher education, commercial and technical institutions and establish or acquire for them libraries reading rooms, science laboratories, gymnasium, workshops, Hostels etc.
 - i) For fulfilling the above objects appoint and make available qualified and deserving teachers, lecturers, skilled technical staff in hygiene and administrator.
 - j) To promote the spread of knowledge and arrange lectures etc. for the same.
 - k) To try to get subscriptions, donations, grants, prizes etc. from the public, industrialists and the government & to accept the same.
4. For fulfilling the objectives and work of the institute to collect and hold funds, to purchase land, buildings and other assets to sale or gives the building on rental basis the income of which would help in achieving the objectives of the Institute, if necessary avail loans for obtaining fixed assets. All the rights for doing the above as well as other required things will remain with the institute.
5. Membership Rules :-
 - a) Patron :- One who donates Rs. 1,000/- or more at one time.
 - b) Perpetual Member :- Donating Rs. 500/- at one time.

c) The six perpetual trustees of the institution will be Ex-officer members of the Executive Committee.

6. If any member of the institution acts against the interest, work to defame the institution or behaves in contradiction of the aims and objects of institutions or found guilty is punishable under the law for six months or more, his / her membership can be terminated. However, the Executive Committee shall, by passing a resolution and give in writing the misbehavior of the member, asking an explanation from him for terminating his membership. Afterwards the matter should be given to the member to defend himself. After giving such a chance, the resolution should be passed in the general meeting terminating the membership of the said member and communicate in writing regarding the same.

- b) If the post of any one the perpetual trustees becomes vacant, for what so ever reasons the same will be filled up at a general meeting by not less than 2/3rd majority of the members.

8. The Executive Committee will work under the directives of general body and will handle the day to day affairs of the institutions. The Executive committee will be elected at the annual general meeting and the tenure of the Executive committee will be of 5 years. There will be a total of 11 members of the Executive committee.

As the office bearers. The office bearers will be elected in the first meeting of the Executive Committee.

9. The tenure of the Executive Committee will be up to the election of the new committee at the fifth annual general meeting of the institution.

10. If there is a vacant post of any Executive Member, for what so ever reason, it will be accepted and filled up only by the Executive Committee. New member's tenure will be the same of Executive Committee.

11. Accounting Year :-

The accounting year of the Institution will be from 1st April to 31st March.

12. Annual General Meeting :-

- a) The Executive Committee shall call the annual general meeting before 30th September every year.
- b) If 2/3rd members ask in writing for a general meeting, the President should call such meeting within 15 days.

13. The Work Of The Annual General Meeting :-

- a) To review the work (of the institution) during the last year and to approve annual A/c's.
- b) To elect new Executive Committee, if necessary.
- c) To approve the budget for the next year.
- d) Give instructions, if necessary to the Executive Committee.
- e) To consider cancellation of the membership of a member.
- f) To consider empowering the Executive Committee to held funds or acquire property.
- g) To consider any other subject with the consent of President.

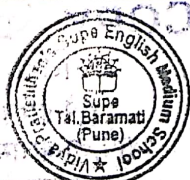

14. Duties Of The Executive Committee:-

- To take care of the day to day work of the institution.
- To maintain accounts and get audited.
- To employ person or discontinue employment of persons.
- To make investments of the institutions funds as per the instructions of the general body.
- To make necessary arrangements for the working of institution.
- To approve the applications of intending new members.
- To fill up a vacancy caused in the Executive Committee.

15. Meeting of the Executive Committee :-

- The Secretary should call a meeting of the Executive Committee at least once, or more than once if needed, within a period of 2 months.
- If a such meeting is not called, meeting should be called within 15 days by the president, if asked for by at least 5 members.
- Every meeting of the Executive Committee shall have on its Agenda.
 - To review the work done.
 - Approve bimonthly accounts of the institutions.

16. The general meeting will have powers to amend the constitution of the institution. However, such amendment must be shown on the agenda of the general meeting. The constitution will not be amended unless supported by 2/3 of the total members of the institution.

17. Notice of Meeting :-

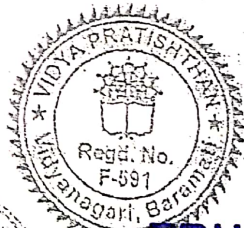
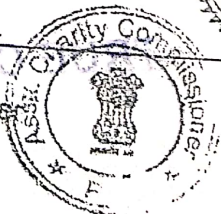
Notice of the annual general meeting or any general meeting must reach the members at least 7 days before the due date of the meeting. Notice of the meeting of the Executive Committee should be given so as to reach the members at least 3 days before the meeting. However, in case of emergency there will not be any necessary of the period for calling such a meeting.

18. Quorum of Four will be necessary for the meeting of the Executive Committee & 15 for the general meeting. If a meeting is post-poned for want of quorum there will be no necessity of notice or quorum for holding a postponed meeting. It will be deemed that a member has received the notice of the meeting if sent by post at the registered address of the member.

19. The institution will be dissolved according to the registration rules 1862 clauses 13 & 14.
