**Terms & Conditions:**

1. The school shall abide by:

- The Right of Children to Free and Compulsory Education Act, 2009,
- Maharashtra Rules of 2011 under the RTE Act,

- All directives, norms, and standards prescribed by the government or its authorized agencies from time to time.
- 2. The norms and conditions as per the Maharashtra Self-Financed Schools Act, 2022 and Rules, 2020 must be strictly followed by the Trust/Company/Institution.
- 3. The school must obtain affiliation from **CBSE or ICSE or IGCSE or IB or other recognized boards** and submit documentary proof as per the government norms.
- 4. The school must inform the **District Education Officer** about the approved academic year for commencement.
- 5. Recognition is **granted only for the approved academic year**. For extension in future years, approval must be obtained.
- 6. If the school does **not begin operations within 18 months**, this recognition will be automatically cancelled.
- 7. Once recognition is granted for a specific school name, location, and structure, it cannot be transferred or altered.
- 8. If the school is relocated without government approval, the recognition shall be null and void.
- 9. Teachers and staff must be appointed as per government norms and qualifications under the Act.
- 10. Upon entering UDISE information, the school shall be registered under "Self-Financed School" status.
- 11. A board with the words "**Recognized Self-Financed School**" must be displayed prominently on school premises.
- 12. If any conditions of this Act or related rules are violated, or if required norms and criteria are not met, the **recognition may be withdrawn**.
- 13. The school must comply with:
  - GR dated 02 June 2018 regarding student safety,
  - Circular dated 21 August 2019 regarding mandatory safety provisions and implementation.
