

AFFIDAVIT

I, Ashok Khandve S/O Dnyanoba Khandve, Age- 60 yrs, President of Mauli Multipurpose Organisation running Brilliant International School, Lohagaon, Pune- 411047 do hereby solemnly affirm and sincerely state as follows:



1. Mauli Multipurpose Organizations a registered Trust under the Indian Trusts Act, 1882.
2. That Mauli Multipurpose Organization of Non-Proprietary Character.
3. That the school is being as a community service and not as a business that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the Institution is being and will be diverted to the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and correspondent/ Manager of the school have duly gone through the provisions contained in the affiliation & examination by laws and the circulars issued by the Board from time to time to the school undertake to abide by the provisions contained in the affiliation & examination by laws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Health, and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.

11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not force any student/parent buy book / stationary/ uniform to any particular shop.
14. That the school shall strive to make efforts for conservation of environment.
15. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will fulfil all other conditions post affiliation and comply with all the general rules as given in the affiliation bye laws or notified from time to time.
16. That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/ affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the post affiliation condition in affiliation bye laws along with general rules.
17. That State pattern classes IX to XII rung prior to the affiliation to CBSE would be sponsored for the State Board Examination. State Pattern classes IN to XII will be closed in phased manner. No admission will be taken in the State Board Pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.

18. That no member of School Managing Committee is related to each other.
