1. We the member of the executive committee of the PTA of Dr. Kalmadi Shamarao High School, Ganesh Nagar Pune 411038 school have unanimously decided that the Fees for students of our school from Std. V to X is to be increased by 15% for two academic years i.e., 2026-27 & 2027-28.
